

## North Dakota Aeronautics Commission

Wednesday, May 22<sup>nd</sup>, 2024 – 1:00 PM Aeronautics Commission Conference Room Bismarck, ND

Chair Kyle Humann called the meeting of the North Dakota Aeronautics Commission to order at 1:00 PM on Wednesday, May 22, 2024, and roll call was taken.

3/26/24 Meeting Minutes – Minutes approved as is.

Financial Statements – Gaye reviewed March and April 2024 financial statements.

**Aviation Education Grant EDU23-06 Kindred High School Aviation Program** – Mike reviewed the Kindred Education Request with the commission. Scott Bartram was in attendance to thank the commissioners for the past grant and explained what they have been doing with those funds. The Kindred High School is asking for an additional grant to purchase a standing desktop and a simulator with better graphics. The Drone Club has been meeting once a week and flying the drones that they received from UND a couple of years ago. Steve moved to approve the grant as requested. Kim seconded the motion. Kim – y Warren- y, Steve – y, Rodney – y, Kyle – y. Motion carried.

**2025-2027 Biennium Budget Guidelines** – Gaye and Kyle provided a review of Governor's Biennium budget guidelines for the following biennium. The commissioners will be asked to review and approve a budget to be submitted to OMB and the Governor's office for review later this summer.

NDAC Staff Activity Report – The Commissioners reviewed the staff activity report.

**FAA Reauthorization Update** – Kyle provided a high-level review of the recently passed FAA Reauthorization bill. The full bill text was close to 1,100 pages long and a section-by-section summary was previously sent out to the commissioners.

**Review IPG Airport Bids and Project Approval** – Kyle reviewed the International Peace Garden rehabilitation project with the commission. It has been over 20 years since the last major rehabilitation of the IPG runway occurred and preparing for this project has been a few years in the making. Kyle also reviewed the bidding information, and the finalized project dollar amounts with the commission. He reiterated that the bids for completing the entire budget exceeded the original amount that was budgeted for the project.

Kyle explained the process of going before the Emergency Commission to request additional appropriation authority from the NDAC Special Fund be allocated to complete this project. Kyle provided the commissioners with a draft of the request that would be submitted to the Emergency Commission.

Kim moved to approve the acceptance of the low bid contractor for the Base Bid and Alternate #1a and #2a. This approval also grants the ND Aeronautics Staff approval to apply for federal grant funds and sign contracts for the project. This acceptance is predicated upon approval of the ND Aeronautics Commission's request to the State Emergency Commission to increase appropriation authority to cover the remaining shortfall on the project. Steve seconded the motion. Kim – y, Warren – y, Steve – y, Rodney – y, Kyle – y. Motion carried.

**Crack Sealing Project Procedure Review** – Adam and Grant reviewed the crack sealing procedures that have changed from last year's grant round and provided the commission with a listing of all the quotes the GA airports received for their 2024 crack sealing projects. All airports received at least two quotes, and all were successful in obtaining significantly lower project prices than during the last construction season. Some minor changes to the crack sealing procedures is expected for next year; however the staff is excited to see the new procedures have resulted in considerable cost savings in crack sealing projects.

**Airport Grant Recommendations** – Adam and Grant presented the grant requests and recommended awards for both the Commercial and GA Airports and provided their recommendations to the Commissioners. Discussion and deliberation occurred on multiple airport projects and the commission made a few adjustments to the final awards.

Kim made the motion to approve the airport grant awards, as follows: The grant spreadsheets denote which projects are designated to receive funding from the different state funding sources that are available. The Airport Infrastructure Fund allocation is approved in the amount of \$9,877,203. Additionally, a 2023-2025 Aeronautics Commission Special/General Fund allocation is approved in the amount of \$5,946,204. This results in a total approved grant allocation of \$15,823,407. Steve seconded the motion. Kim – y, Warren – y, Steve – y, Rodney – y, Kyle – y. Motion carried.

**Chair and Vice Chair election** – Kim made a motion to elect Rodney Schaaf as the new incoming Vice Chair beginning July 1<sup>st</sup>. Warren second the motion. All yays, no nays. Motion carried. Kim will also automatically move from the Vice Chair to the Chair position beginning July 1<sup>st</sup>.

**Review of Agency GEN Policies** – The North Dakota Aeronautics Commission GEN policies are reviewed and approved every three years and are up for review and approval in 2024. Kyle provided the Commission with Policy GEN-1 through GEN-11. Mike had expressed interest in proposing changes to GEN-8, however additional discussion will need to occur at a future Commission meeting. Kim moved to approve GEN-1 through GEN-11 as currently written. Steve seconded the motion. All yays, no nays. Motion carried.

**Update on PCI Project** – Grant provided an update on the PCI project to the Commission. The federal grant application has been submitted to the FAA and the staff is expecting the AIP grant to be received by the end of June. This is positive news for the inspection schedule as the goal is still to complete all airport inspections this summer.

**Update on SASP & Economic Impact Study** – Adam provided the Commission with updates for the System Plan and Economic Impact Study. He mentioned that the project scope has been approved by FAA and the staff will be receiving and independent fee review and begin negotiations in the coming month.

**Discuss Logoed Clothing Options** – Gaye discussed the opportunity for Commissioners and NDAC staff to be provided with NDAC logoed clothing to be worn for official work events and conferences. Once the website is set up, she will then provide everyone with the link and the guidelines for making purchases.

**Discuss Board Training Opportunity** – Gaye explained of an opportunity through the NDSU Extension office, that provides a training session for new and current boards, committees, councils, and commissions. The Commission discussed the idea of arranging this training for NDAC staff and commissioners sometime in the late fall/early winter.

**Discuss NASAO Conference Opportunity** – Kyle discussed this year's NASAO annual conference that will occur in Pittsburgh in early September. He explained the benefits of the event and he recommended that the Commissioners consider attending it to learn and visit with other states.

**Building 22 Update** – Kyle updated the Commissioner's on the status and timeline of our continued use of office space in Building 22. A committee may need to be assembled in the near future to assess the options to move to another location. The Commission will be updated as any new information related to the timing of relocation is known.

**NDAA Update -** Mike gave an update to the Commission on the state of the North Dakota Aviation Association. Renee Murisch has recently been hired as the Association Manager. Plans are currently processing for Summerfest in Devils Lake in early August. The Association is also looking at making the Quarterly Newsletter being provided to a majority of readers in virtual format with printed copies being available to paying members.

**Director Evaluation** – Kyle H. thanked Kyle Wanner for consistently doing a fantastic job in leading the organization. Kim moved to adopt the salary increase that was recommended for Kyle W. Steve seconded the motion. All yays, no nays. Motion carried. A memorandum on this decision will be provided for the office to be kept on file.

**Old Business** – Steve reminded everyone of the upcoming Fargo Airsho being held July 27<sup>th</sup> and 28<sup>th</sup>, 2024.

**Other business** – The Annual Grant Meeting will be held at the Bismarck Airport Terminal on Thursday, June 6<sup>th</sup>, beginning at 9:00 a.m. Agenda and information on that meeting will follow.

The next Commission meeting is then tentatively planned to occur on the morning of August 6<sup>th</sup>.

Meeting adjourned at 5:20 p.m.
